1. The result of the Combined Competitive Examination (Main) for the Recruitment to the posts of Gujarat Administrative Service, Class-1, Gujarat Civil Service, Class-1 & 2 and Gujarat Municipal Chief Officer Service, Class-II, (Advertisement No. 40/2018-19); written test held on 17th & 24th February & 3rd March, 2019 and personal interview test held during 10<sup>th</sup> to 28<sup>th</sup> June, 2019 is hereby declared as per **Annexure-I**
2. The above result is declared taking into consideration the provisions of the Gujarat Administrative Service Class I, the Gujarat Civil Service (Class I & Class II) and the Gujarat State Municipal Chief Officers' Service Class-II, Competitive Examination Rules, 2017 and amendments made thereafter from time to time and other relevant applicable criteria.
3. As provided in the Gujarat Administrative Service Class I, the Gujarat Civil Service (Class I & Class II) and the Gujarat State Municipal Chief Officers' Service Class-II, Competitive Examination Rules, 2017 and amendments made thereafter from time to time,
  - (i) As per Rule-17(1) : the merit has been determined on the basis of the aggregate marks (total marks) awarded to the candidates in the Main Examination (i.e. 900 marks of written examination and 100 marks of viva-voce test = Total 1000 marks)
  - (ii) As per Rule 17(4) : **No Waiting List** is prepared by the Commission.
  - (iii) As per Rule 18 : the candidate, who fails to attend the Personality Test (remains absent in Viva-Voce), is not considered as eligible for selection.
  - (iv) As per the Rule 9 (2) (b) where a candidate has not given preference for any post, or the candidate has given preference only for few posts, and the number of posts for which he has given preference are not available to accommodate the candidate as per his preference, he/she shall be

allotted to any of the remaining Vacant posts after allocation of all the candidates to the posts in accordance with their preferences.

4. (i) The Reserved Category Candidates (SC / ST / SEBC), who get either equal or more than minimum marks fixed as qualifying standard for general candidates and have not availed of any relaxation in age, qualifying standard etc. at any point of the examination process (Meritorious reserved Category {MRC} Candidates) have been selected against unreserved posts as per their preference in order of merit
  - (ii) The Reserved Category Candidates, though have secured their place in the merit of general category, but due to better preference available to them, they are selected against the posts reserved for their respective categories in accordance with the Judgement of the Honourable Supreme Court in the case of Union of India versus Ramesh Ram and others (Civil Appeal No. 4310-4311 of 2010) [Arising out of SLP(C) Nos. 13571-72 of 2008].
  - (iii) The Reserved Category candidates, who have though secured their place in the merit of General category, however, they are selected against the posts of their respective categories as they have availed the benefit of relaxation in age/ Cut-Off Marks in P.T. or Main Written Examination as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004.
5. (A) PD (Physically Disabled) Candidates have been considered under their respective category after relaxing upto 10% marks of the Qualifying Standard fixed for their respective category. The PD candidates who have attained the relaxed qualifying standard within the category are re-arranged in the order of merit of disabled category. While considering for a post, special reference has been made to the preference of posts given by the candidate, applicable disability Level & Type of disability for the post, 10% relaxed qualifying standard for the cadre post within the respective category and cadre-wise posts reserved for PD candidates as provided in the Recruitment Advertisement. All such candidates are accommodated against the reserved posts for disabled candidates, in their respective categories.

- (B) The candidate under Ex-Serviceman category has been considered under his respective category after relaxing upto 10% marks of the Qualifying Standard fixed for his respective category. While considering for a post, special reference has been made to the preference of posts given by the candidate, applicability to the post, 10% relaxed qualifying standard for the cadre post within the respective category and cadre-wise posts reserved for Ex-Serviceman Category candidates as provided in the Recruitment Advertisement.
- (C) As per the instruction of circular No. CRR-1096-2213-G.2, Dated: 31.08.2004 of General Administration Department & O.O. No. अ८अ-1095-206-Part-V-R&D, dated 20/07/2015 of the Commission, the result of the widow candidates is prepared after addition of Bonus Mark in the applicable Stage of Examination Process. Bonus marks is 5% marks of the obtained marks by the candidate.
- (D) In case of equal marks, the merit was assigned taking into consideration the date of birth (i.e. preference is given to the elder).
- (E) The result is prepared following the ratio laid down by the following Judgements of the Hon'ble Supreme Court:
- (i) Rajesh Kumar Daria V/s. Rajasthan Public Service Commission, - Civil Appeal Nos. 3132 of 2007, 3773 of 2007 decided on 18-07-2007.
  - (ii) Public Service Commission, Uttaranchal V/s. Mamta Bist & Others, - Civil Appeal Nos. 5987 of 2007, with Civil Appeal No.5982 of 2007 decided on 03-06-2010.
  - (iii) Union of India V/s. Ramesh Ram and Others - Civil Appeal Nos. 4310, 4311 of 2010 [arising out of SLP(C) Nos.13571-72 of 2008] decided on 07-05-2010.

6. In paragraph No,-5 of the Judgement delivered in the case of **Rajesh Kumar Daria V/s. Rajasthan Public Service Commission, (Dated:18-07-2007)**, the Hon'ble Supreme Court has laid down the following principles:

*"Before Examining whether the reservation provision relating to Women, had been correctly applied, it will be advantageous to refer to the nature of horizontal reservation and the manner of its application, In Indra Sawhney V/s. Union of India (1992 SUPP.(3)SCC 217), the principle of horizontal reservation was explained thus (Pr,812):*

*"all reservations are not of the same nature. There are two types of reservation, which may, for the sake of convenience, be referred to as 'vertical reservations' and 'horizontal reservation'. The reservation in favour of Scheduled Castes, Scheduled Tribes and Other Backward Classes (under Article: 16(4) may be called vertical reservation, whereas reservations in favour of physically handicapped (under Clauses (1) of Article 16) can be referred to as horizontal reservations. Horizontal reservation cut across the vertical reservations - what is called interlocking reservations. To be more precise suppose 3% of the vacancies are reserved in favour of physically handicapped persons; this would be a reservation relatable to clause (1) of Article 16. The persons selected against the quota will be placed in that quota by making necessary adjustments; similarly, if he belongs to open competition (OC) category, he will be placed in that category by making necessary adjustments. Even after providing for these horizontal reservations, the percentage of reservation in favour of backward class of citizens remains - and should remain - the same.'*

*A special provision for women made under Article 15(3), in respect of employment, is a special reservation as contrasted from the social reservation under Article 16(4). The method of implementing special reservation, which is a horizontal reservation, cutting across vertical reservation, was explained by this Court in Anil Kumar Gupta V/s. State of U. P. (1995(5) SCC 173) thus:*

*"The proper and correct course is to first fill up the Open Competition quota (50%) On the basis of merit; then fill up each of the social reservation*

*quotas, i.e. S.C., S.T. and B.C.; the third step would be to find out how many candidates belonging to special reservation have been selected on the above basis. If the quota fixed for horizontal reservations is already satisfied - in case it is an overall horizontal reservation - no further question arises. But if it is not so satisfied, the requisite number of special reservation candidate shall have to be taken and adjusted / accommodated against their respective social reservation categories by deleting the corresponding number of candidates therefrom. (If, however, it is a case of compartmentalized horizontal reservation, then the process of verification and adjustment / accommodation as stated above should be applied separately to each of the vertical reservations. In such a case the reservation of 15% in favour of special categories, overall, may be satisfied or may not be satisfied.) {Emphasis supplied}"*

7. In paragraph No,-13 of the Judgement dated: 03-06-2010 delivered in the case of **Public Service Commission, Uttaranchal Vis. Mamta Bist and Others**, the Hon'ble Supreme Court has laid down the following principles:

*"13. The view taken by the High Court on application of horizontal reservation is contrary to the law laid down by this Court in **Rajesh Kumar Daria V/s. Rajasthan Public Service Commission and others**. AIR 2007 SC 3127, wherein dealing with a similar issue this Court held as under:*

*"9. The second relates to the difference between the nature of vertical reservation and horizontal reservation. Social reservations in favour of SC, ST and OBC under Article 16(4) are "vertical reservations". Special reservations in favour of physically handicapped, women, etc., under Articles 16(1) of 15(3) are "horizontal reservations". Where a vertical reservation is made in favour of a Backward Class under Article 16(4), the candidates belonging to such Backward Class may compete for non-reserved posts and if they are appointed to the non-reserved posts on their own merit, their number will not be counted against the quota reserved for respective Backward Class. Therefore, if the number of SC candidates, who by their own merit, get selected to open competition vacancies, equals or even exceeds the percentage of posts reserved for SC candidates, it cannot be said that the reservation quota for SCs has been filled. The entire reservation quota will be intact and available in addition to those selected under open competition category. (Vide **Indra Sawhney, R.K. Sabharwal***

*V/s. State of Punjab, Union of India V/s. Virpal Singh Chauhan and Ritesh R. Sah V/s. Dr. Y.L. Yamul) But the aforesaid principle applicable to vertical (social) reservations will not apply to horizontal (special) reservations. Whereas special reservation for women is provided within the social reservation for Scheduled Castes, the proper procedure is first to fill up the quota for Scheduled Castes in order of merit and then find out the number of candidates among them who belong to the, special reservation group of "Scheduled Caste women". If the number of women in such list is equal to or more than the number of special reservation quota, then there is no need for further selection towards the special reservation quota. Only if there is any shortfall, the requisite number of Scheduled Caste women shall have to be taken by deleting the corresponding number of candidates from the bottom of the list relating to Scheduled Castes. To this extent Horizontal (special) reservation differs from vertical (social) reservation. Thus women selected on merit within the vertical reservation quota will be counted against the horizontal reservation for women." (Emphasis added)*

8. The Hon'ble Supreme Court in the case of **Union of India V/s. Ramesh Ram and Others** delivered Judgement on 07-05-2010 (in C.A. No.431 0/4311 of 2010 arising out of SLP(C) No.13571-72 of 2008) wherein it has laid down the following principles in paragraphs No.-47 to 50 :

*"47. The proviso to Rule 16(1) and Rule 16(2) operate in different dimensions and it is untenable to argue that these provisions are contradictory or inconsistent with each other. As mentioned earlier, in the examination for the year 2005- 32 reserved candidates (31 OBC candidates and 1 SC candidate) qualified as per the general qualifying standard [Rule 16(1)]. These MRC candidates did not avail of any of other concessions and relaxations in the eligibility criteria at any stage of examination, and further they secured enough marks to place them above the general qualifying standard MRC candidates are entitled to one of the two posts one depending on their performance in the General list and other depending on their position in the Reserved List. When MRC candidates are put in the General list on their own merit they do not automatically relinquish their reserved status. By the operation of Rule 16(2), the reserved status of an MRC candidate is protected so that his / her better performance does not deny such candidate the chance to be allotted to a*

*more preferred service. Where, however, an MRC is able to obtain his preferred post by virtue of his / her ranking in the General list, he / she is not counted as a Reserved Candidate and is certainly not counted amongst the respective reservation quota.*

*48. We must also remember that affirmative action measures should be scrutinized as per the standard of proportionality. This means that the criteria for any form of differential treatment should bear a rational correlation with a legitimate governmental objective. In this case a distinction has been made between Meritorious Reserved Category candidates and relatively lower ranked Reserved Category candidates. The amended Rule 16(2) only seeks to recognize the inter-se merit between these two classes' of candidates for the purpose of allocation to the various civil services with due regard for the preferences indicated by the candidates.*

*49. With regard to the specific characteristics of the UPSC Examinations we hold that Reserved Category candidates (belonging to OBC, SC or ST categories among others) who are selected on merit and placed in the list of general / unreserved category candidates can choose to migrate to the respective reserved categories at the time of allocation of services. Such migration is enabled by Rule 16(2) of the Civil Services Examination Rules, which is not inconsistent with Rule 16(1) of the same or even the content of Articles 14, 16(4) and 335 of the Constitution of India.*

*50. We sum up our answers:*

- (i) MRC candidates who avail the benefit of Rule 16(2) and adjusted in the reserved category should be counted as part of the reserved pool for the purpose of computing the aggregate reservation quotas. The seats vacated by MRC candidates in the General Pool will be offered to General category candidates.*
- (ii) By operation of Rule 16(2), the reserved status of an MRC candidate is protected so that his / her better performance does not deny him of the chance to be allotted to a more preferred service.*
- (iii) The amended Rule 16(2) only seeks to recognize the inter se merit between two classes of candidates i.e.*

- a) meritorious reserved category candidates,*  
*b) relatively lower ranked reserve category candidates, for the purpose of allocation to the various Civil Services with due regard for the preferences indicated by them.*
- (iv) The reserved category candidates, "belonging to OBC~ SC/ST categories" who are on merit and placed in the list of General / Unreserved category candidates can choose to migrate to the respective reserved category at the time of allocation of services. Such migration as envisaged by Rule 16(2) is not inconsistent with Rule 16(1) or Article: 14, 16(4) and 335 of the Constitution.*
9. In view of the above referred Judgments of the Hon'ble Supreme Court, the settled legal position appears to be that the women reservation is interlocutory within each category (SC / ST / SEBC / GENERAL) and the same is horizontal (Special) reservation, and not vertical (Social) reservation and that therefore, the women candidates selected as merit candidates will count towards women reservation quota for each category (i.e. SC / ST / SEBC / GENERAL). Under the circumstances, where a horizontal (Special) reservation is provided for women within each category SC / ST / SEBC / GENERAL, the proper procedure is first to fill up the quota for each category (SC / ST / SEBC / GENERAL) in order of merit and then find out the number of candidates among them who belong to the Special reservation group of " SC / ST / SEBC / GENERAL - Women". If the Women in such list are equal to or more than the number of special reservation quota, then in that case, there is no need for further selection towards the special reservation quota. Only if there is any shortfall, the requisite number of "SC / ST / SEBC / GENERAL - Women" shall have to be taken by deleting the corresponding number of candidates from the bottom of the list of SC / ST / SEBC / GENERAL candidates. To this extent, horizontal (Special) reservation differs from Vertical (Social) reservation. Thus, Women selected on merit within SC / ST / SEBC / GENERAL quota will be counted against the horizontal reservation for women.
10. As per the Apex Court's Judgement in Union of India V/s. Ramesh Ram and Others, decided on 07-05-2010, Meritorious Reserved Category Candidates (MRC), who have availed any of the benefits / relaxations available to a Reserved Category Candidate, should be counted as part of the reserved pool for the purpose of computing the aggregate reservation quota. However, the



MRC candidates who have not availed any of the benefits / relaxations available to a Reserved Category Candidate at any stage of the examination process will have to be considered as a Reserved Category Candidate, if he/she gets a more preferred service / post because of his /her being treated as a Reserved Category Candidate. In that eventuality, the reserved status of an MRC candidate is protected so that his / her better performance does not deny him the chance to be allotted to more preferred service. Accordingly, the MRC candidates are treated as RC candidates for the purpose of allotment of their preferred post.

11. It needs to be clarified that the result of the examination under reference given in the **ANNEXURE-I (Part-1)** has been prepared by strictly applying the ratio laid down by the Apex Court in the cases of (i) Public Service Commission, Uttaranchal V/s. Mamta Bist and Others – Civil Appeal Nos. 5987 of 2007, with Civil Appeal No. 5982 of 2007 decided on 03-06-2010 and (ii) Union of India V/s. Ramesh Ram and Others - Civil Appeal Nos. 4310, 4311 of 2010 (arising out of SLP(C) Nos.13571-72 of 2008) decided on 07-05-2010.
12. With regard to women reservation as provided for in the Government Notification GAD No. GS/97-13-CRR/1096/2213/G-2, dated 9th April, 1997, GAD Circular No. CRR/1096/2213/G-2, dated 22/05/1997, GAD Notification No. GS/2014/37/CRR/1096/2213/G-2 (Part-I) dated 11/11/2014 and GAD G.R. No. CRR/1096/2213/G-2, dated 01/08/2018, 85 women candidates (General-47, SEBC-19, S.C.-05 and S.T.-14) are required to be selected. As against this, 47 women candidates of General category (i.e. Merit Nos. 03, 05, 22, 25, 26, 44, 74, 75, 79, 88, 89, 98, 99, 103, 110, 112, 116, 120, 123, 126, 127, 136, 149, 157, 164, 166, 174, 176, 177, 178, 189, 191, 195, 196, 202, 208, 209, 212, 213, 214, 217, 220, 221, 226, 232, 234 and 235), 19 women candidates of SEBC category (i.e. Merit Nos. 8, 17, 115, 187, 192, 215, 224, 228, 229, 230, 233, 236, 238, 239, 241, 242, 243, 244 and 245) 06 women candidates of S.C. category (i.e. Merit Nos. 14, 35, 41, 43, 169 and 210), 14 women candidates of S.T. category (i.e. Merit Nos. 86, 256, 262, 266, 267, 275, 280, 283, 285, 287, 290, 291, 292 and 293), thus, total 86 women candidates have been selected.
13. The following 11 reserved category candidates (MRC), who have got either equal or more than the Cut-off Marks for General category candidates and have not availed any relaxation in age, Cut-off Marks etc. are to be recommended

against unreserved posts as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004.

1. The SEBC candidates at Merit Nos. 01, 07, 10, 13 and 132 = total- 05.
2. The S.C. candidates at Merit Nos. 97, 143 and 183 = total- 03.
3. The SEBC Female candidates at Merit Nos. 08 and 17 = total- 02.
4. The S.C. Female candidates at Merit No. 41 = total- 01.

As per the Government GAD G.R. No. CRR/1096/2213/G-2, dated 01/08/2018, the above stated 03 reserved category Female candidates (MRC), are to be recommended against Unreserved Common posts and have been counted against their respective categories.

14. The following 43 candidates, though have secured their place in the merit of general category, but due to better preference available to them, they are selected against the posts reserved for their respective categories in accordance with the Judgement of the Honourable Supreme Court in the case of Union of India versus Ramesh Ram and others (Civil Appeal No. 4310-4311 of 2010) [Arising out of SLP(C) Nos. 13571-72 of 2008].
  - (i) The SEBC candidates at Merit Nos. 32, 33, 36, 42, 52, 54, 56, 62, 64, 66, 70, 71, 82, 84, 91, 96, 102, 104, 107, 111, 113, 117, 124, 131, 139, 150, 151, 154, 155, 159, 167, 168, 170 and 182 = total- 34.
  - (ii) The S.C. candidates at Merit Nos. 93, 108, 129, 141, 162 and 181 = total- 06.
  - (iii) The S.C. Female candidates at Merit No. 35 = total- 01.
  - (iv) The S.T. candidate at Merit No. 80 = total- 01.
  - (v) The S.T. Female candidate at Merit No. 86 = total-01.

15. The following 05 reserved category candidates, who have though secured their place in the merit of General category, however, they are selected against the posts of their respective categories as they have availed the benefit of relaxation in age/ Cut-Off Marks in P.T. or Main Written Examination as per

Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004.

(1) The SEBC candidates at Merit Nos. 115 (Fem.) and 128= total 02.

(2) The S.C. category Female candidates at Merit Nos. 14, 43 and 169= total 03.

16. While going through the process of recruitment, total 04 General category Disabled candidates, bearing E. Nos. 773, 213, 539 and 911 (at Overall Rank Nos. 340, 505, 554 and 648 respectively) were available for consideration for selection, after relaxing up to 10% marks of the Cut-off Marks fixed for General category. While considering for the allotment of the posts, special reference has been made to the preferences of the posts given by the candidates, applicable disability level and type of disability for the post and cadre-wise posts reserved for the disabled candidates, as provided in the advertisement.

While going through the process of cadre wise allotment of the posts to these candidates, 10% marks of the Cut-off Marks for each cadre was taken in to consideration along with their preference and posts reserved for their respective categories and notified in the advertisement.

- (a) While considering cadre wise allocation of GAS cadre posts to General-Disabled Male candidates, all the 17 GAS cadre posts of General Male category are allocated, in order of merit and the Cut-off Marks for GAS cadre posts of General category is derived, which is 486.25 marks. Then after subtracting 10% Marks from the Cut-off Marks for GAS cadre, the Cut-off Marks for GAS cadre for the Disabled candidates (General) is derived i.e. 437.62 Marks (i.e.  $486.25 - 48.63 = 437.62$  Marks). The General-Disabled Male candidate at Merit No. 237 (E.No. 773) has obtained total 440.75 Marks i.e. above 437.62 Marks and hence, he has been allocated/ accommodated in the GAS cadre post (i.e. his first available preference).
- (b) While considering cadre wise allocation of Section Officer (Sachivalay), cadre posts to General-Disabled Male candidates, all the 06 S.O. cadre posts of General category (Common) are allocated, in order of merit and the Cut-off Marks for S.O. cadre posts of General category is derived, which is 472.75 marks. Then after subtracting 10% Marks from the Cut-off Marks for S.O. cadre, the Cut-off Marks for S.O. cadre for the Disabled

candidates is derived i.e. 425.47 Marks ( $472.75-47.28= 425.47$  Marks). The General-Disabled Male candidate at Merit No. 246 (E.No. 213) has obtained total 431.50 Marks i.e. above 425.47 Marks and hence, he has been allocated/ accommodated in the S.O. (Sachivalay) cadre post (i.e. his second preference).

- (c) While considering cadre wise allocation of S.T.O cadre posts to General Disabled candidate, all the 15 S.T.O. cadre posts of General category (Common) are allocated, in order of merit and the Cut-off Marks for S.T.O. cadre posts of General category is derived, which is 456.75 marks. Then after subtracting 10% Marks from the Cut-off Marks for S.T.O. cadre, the Cut-off Marks for S.T.O. cadre for the Disabled candidates is derived i.e. 411.07 Marks ( $456.75-45.68= 411.07$  Marks). The General Category Disabled Male candidate at Merit No. 247 (E.No. 539) has obtained total 428.75 Marks i.e. above 411.07 Marks and hence, he has been allocated/ accommodated in the S.T.O. cadre post (i.e. his first available preference).
- (d) While considering cadre wise allocation of T.D.O. cadre posts to General-Disabled candidates, all the 11 T.D.O. cadre posts of General category are allocated, in order of merit and the Cut-off Marks for T.D.O. cadre posts of General category is derived, which is 459.50 marks. Then after subtracting 10% Marks from the Cut-off Marks for T.D.O. cadre, the Cut-off Marks for T.D.O. cadre for the General-Disabled candidates is derived i.e. 413.55 Marks ( $459.50-45.95=413.55$  Marks). The General category Disabled candidate at Merit No. 251 (E.No. 911) has obtained total 423.25 Marks i.e. above 413.55 Marks and hence, he has been allocated/ accommodated in the T.D.O. cadre post (i.e. his first available preference).
17. The first available meritorious S.C. category candidate, with aggregate 463.25 Marks, for consideration of allotment to the post of Section Officer (Sachivalay) cadre has not been allotted Section Officer (Sachivalay) cadre post as 01 post is reserved for Ex-Serviceman in Section Officer (Sachivalay) cadre. The Cut-off Marks derived for consideration of Ex-Serviceman candidate for S.O. cadre post, is 416.92 marks after relaxing up to 10% marks of the Marks obtained by

the afore said candidate (i.e.  $463.25-46.33=416.92$ ). The Ex-Serviceman candidate at Merit No. 199 (E.No. 753) has obtained total 449.75 Marks i.e. above 416.92 Marks and hence, he has been allocated/ accommodated in the Section Officer (Sachivalay) cadre.

18. As per the Rule 9 (2) (b) of the Gujarat Administrative Service Class I, the Gujarat Civil Service (Class I & Class II) and the Gujarat State Municipal Chief Officers' Service Class-II, Competitive Examination Rules, 2017 and amendments made thereafter from time to time, the Candidates with limited preferences, at Merit Nos. 29, 49, 53, 57, 59, 69, 72, 78, 95, 97, 98, 100, 122, 126, 132, 133, 140, 153, 157, 158, 164, 176, 189, 193, 205, 216, 224, 226, 228, 239, 236, 239, 243, 263, 274, 275, 282, 287 and 292 (total 39 candidates), have been allotted (indicative allotment) the posts, which remained vacant, after allocation of posts to all the candidates, in accordance with their preferences.
19. As per the instructions issued vide Government circular GAD No. CRR-1096-2213-G-2 dated 31/8/2004, 5% marks of the marks obtained by a widow candidate is to be added to the marks obtained by her at every stage. The candidate bearing E.No. 474, belongs to SEBC Category and has obtained 50 marks in Viva Voce. 5% marks are added to her obtained marks (i.e.  $50 + 2.50=52.5$ ), as per the provisions of the O.O. No. ૪૮૪-1095-206-Part-V-R&D, dated 20/07/2015. She has obtained aggregate 423.25 Marks ( $370.75+52.5=423.25$ ) which is less than the Cut-Off marks of her category, hence she is to be declared unsuccessful.
20. The candidature of the candidate bearing E No. 143 has been cancelled for not producing required degree certificate at the time of Interview.
21. The Hon'ble High Court vide its oral order dated 24/06/2019 in S.C.A. No. 10807 of 2019, has directed the Commission to keep 01 post vacant and hence 01 post of General category is kept vacant as the petitioner belongs to General category.

**Note :-**

1. The mere success in the examination shall not confer any right to appointment and no candidate shall be appointed to the post unless the

Government is satisfied, after such inquiries as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

2. The order of preference for the posts indicated by the candidate shall not confer any right to him for appointment to such posts. Having regard to the rank in the order of merit and the number of posts available, the preference given by the candidate shall be considered and appropriately allotment will be decided by the Government at the time of appointment.
3. The above result is subject to revision after rechecking of marks of those candidates who apply for the same.

6. **Applications received beyond the above time limit shall be not considered.**
