Special Education Teachers (Guest) who have been re-deployed/re-allocated schools are hereby directed to report for joining in the concerned school **within five working days** along with following documents for verification by the concerned HOS:

1. Copy of online Registration slip/Application Form.
2. Copy of latest online generated relieving letter, having clearly mentioned reason of relieving of last attended school and copies of online generated experience certificates duly signed by concerned HOS.
3. Original and one set of self attested photocopies of all relevant educational qualifications (both sides) like year wise Mark sheets/Certificates, Provisional/Degree (from 10<sup>th</sup> onwards). Candidates without certificate, degree or provisional will not be entertained.
4. Original and self attested photocopy of CTET certificate.
5. Original and self attested photocopy of RCI Registration certificate.
6. Identity Proof (preferably Copy of Aadhar card).

Further, concerned HOS are directed to take following action for the engagement of Special Education Teacher (Guest) for session 2019-20:

1. Give the concerned Special Education Teacher (Guest) online joining if the teacher fulfils all eligibility condition for Special Education Teacher as per the existing RRs for the post in Directorate of Education.
2. Generate online engagement letter
3. **Ensure the online relieving from previous school before providing engagement to the candidates.**


The HOS of current schools are hereby directed that the Special Education Teachers (Guest) mentioned in Table B shall be relieved immediately and those mentioned in Table A should be relieved only after joining of Special Education Teacher (Regular), if not yet joined.

Further, the HOS of current schools (in Table A & B) are also directed that while relieving the Special Education Teacher (Guest), online relieving letter and experience certificate should be issued.

Mere allotment of school does not guarantee the engagement of the candidate; it is further subject to the availability of vacancy at the time of reporting in the allotted school and fulfilment of eligibility criteria as per existing RRs of DOE.
