**Subject: Status of selection process for the posts of Lecturer Super Specialty (Medical Oncology) (GMC Srinagar) in Health & Medical Education Department.**

Whereas, the Health & Medical Education Department referred 03 posts [OM:01, RBA:01 & SC:01] under Open Merit of Lecturer Super Specialty (Medical Oncology) (GMC Srinagar) to the Public Service Commission for being filled up from amongst the suitable candidates; and

Whereas, the Commission notified this post vide Notification No. 03-PSC(DR-P) of 2016 dated:19.02.2016; and

Whereas, in response to the above notification, **04** applications were received, were found eligible and called for interview; and

Whereas, 01 more candidates was allowed to participate in the interview on the directions of the Hon'ble High Court in WP (C) No. 1950/2019, CM No.3729/2019 titled Dr. Syed Nisar Ahmad Vs State of J&K & others. The operative parts of the directions are reproduced as under:-

***“...meanwhile, subject to objections, respondent no. 02 is directed to ensure participation of the petitioner in the selections proves and conduct his interview scheduled to be held on 17.06.2019 for the post of Lecturer Medical Oncology advertised in terms of Notification No. 03-PSC (DR-P) of 2016 dated: 19.02.2016”.***

Whereas, the interviews of the candidates were conducted on 17.06.2019 with the assistance of experts from outside the State; and,

Whereas, 01 post each under RBA and SC category left vacant due to non-availability of the candidates.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the list of candidates who have appeared in the interview is enclosed as Annexure-“A” to this Notification.

Consequent upon the above, **Dr. Mohd. Hussain Mir S/O Sh. Ghulam Qadir Mir R/O Near Masjid Usmania Dalwatch Gagisgund Doru**, who has secured **64.28 points** is recommended for selection against the available post under **Open Merit**.

1. The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. The Select List is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
